# Georgia General Assembly Convened January 10<sup>th</sup>

"In the event that a Member experiences any of these symptoms [listed below] after the start of the 2022 Legislative Session, he or she should immediately leave the Capitol Complex (if present there) and should not return to the Capitol Complex until they have visited a doctor and received clearance to return."

#### **COVID-19 Requirements for the Capitol Complex**

- Members of the House Representatives were tested January 5<sup>th</sup> at the Capitol, while testing at other locations must have been done by Friday January 7<sup>th</sup>.
- House Staff were tested at the Capitol on January 5<sup>th</sup>.
- Test results were sent to Human Resources Director Donald Cronin by January 10<sup>th</sup>.
- The Speaker may remove from the House Chamber and Gallery those refusing to comply.
- Masks must be worn by House Members and staff when in the House Chamber or Gallery.
- Members, staff and public attendees must wear masks to enter committee meetings.
- Committee and sub-committee meetings are live-streamed where technology is available.
- Members who wish to participate virtually must give a 24-hour notice.
- Public attendees of committee meetings must register name, address and contact numbers.
- Registration lists may be used for contact-tracing when COVID-19 infection emerges.
- Social distancing in the House requires 15 representatives to be seated in the Gallery.
- Specifically programmed tablets allow members in the Gallery to vote, etc.
- Food brought in must be covered in single-portion containers or individually wrapped.
- Masks are encouraged for Members and staff, except when ingesting food or beverages.
- Monday and Thursday are the twice-weekly test days. Except for the second week, testing will be on Tuesday and Thursday, after MLKJr holiday is observed Monday January 17<sup>th</sup>.

#### **Capitol Complex Changes for Visitors and Volunteers**

- Entry into the Capitol is limited to approximately 800 visitors at any given time.
- Capitol complex meeting spaces cannot be reserved for use by outside groups.
- Vending machines for food and beverages are available on the first floor of the Capitol.
- Masks are encouraged but not mandatory for entry into the Capitol.
- There is no "rope line" or pages to allow prompt in-person communication with legislators.
- Communication with legislators is available by appointment, but not by casual approach.
- Black curtains restrict public access to the corridor outside the Chambers.
- The Gallery is not accessible to the public and its corridor is not open to the public.
- Personal aides and staff not paid by the House are not allowed to work in House offices.
- A personal aid or chief of staff must work remotely or from public spaces in the Capitol.

#### Mike's Memo about Sanctity of Human Life Day

"In 1984, President Ronald Reagan proclaimed that January 22 would be the first National Sanctity of Human Life Day because it is the anniversary of the Supreme Court decision to legalize abortion-on-demand in the U.S. in 1973.

"Churches traditionally recognize the third Sunday of January as Sanctity of Human Life Sunday, which would be January 16 in 2022.

"However, some churches may choose the Sunday closest to the anniversary of *Roe vs. Wade*, which would be Sunday, January 23, 2022.

"The attached<sup>3</sup> bulletin inserts are undated so that you can use them on whichever Sunday you choose.

"This year will be the 49<sup>th</sup> anniversary of the legalization of abortion in America.

"Over 64.5 million babies have lost their lives because of abortion since 1973.

#### **Identify Your State Legislators and get Their Contact Numbers**

To learn your legislators' names, (a) access <a href="https://www.openstates.org/find\_your\_legislator/">https://www.openstates.org/find\_your\_legislator/</a>. Then, (a) enter your address, state and zip code to access the link to your State representative and senator, their districts and contact numbers. (b) Click on the colored block opposite your representative's name to access a picture and contact numbers. (c) Do likewise for your senator. To email them, put a period between their first and last name, then add @house.ga.gov for representatives or @senate.ga.gov for senators. For example, the emails for my legislators are: kim.jackson@senate.ga.gov and zulma.lopez@house.ga.gov.

#### **More Changes Expected during the Session**

During this first week of the 2022 Georgia General Assembly, committee assignments and contact data continue as they were in 2021. But during the recess of January 17-21, necessary changes will affect committee chairmen, committee members and office assignments.

Meanwhile, legislation is being introduced and contact numbers provided herein are based on 2021 committee assignments. Updated contact numbers will be used as they become available. Calls to current numbers will be effective, although committee assignments may change.

**S.B. 316 Offense of Stalking a Minor,** introduced January 10<sup>th</sup> by Senator Jason Anavitarte, adds two strong amendments to current law: (1) Any person over age 18 who stalks a minor would be guilty of a high and aggravated misdemeanor, could be fined \$1,000 to \$5,000 or sent to prison for a year or both. (2) Local school boards would inform students and their parents that some acts of bullying and cyberbullying may constitute stalking and could result in a misdemeanor or felony criminal conviction. Punishment would be a fine, prison or both.

**S.B. 319 Georgia Constitutional Carry Act of 2021,** introduced January 10<sup>th</sup> by Senator Jason Anavitarte, is a 25-page bill changing the word "license holder" to "lawful weapons carrier," which is defined as a person who is not prohibited by law from possessing a weapon or long gun, or who is legally licensed in Georgia or licensed to carry a weapon in any other state whose laws recognize and give effect to a license issued pursuant to this. It clarifies places appropriate to carry weapons – government buildings, schools/zones/functions/buses, places of worship, game and fish events/places, polling places, courts, in vehicles, and concealed carry. **ACTION –** S.B. 319 should be carefully studied to determine whether it improves or damages current gun-carry law. **H.R. 529 Hunting & Fishing in Ocmulgee River Corridor,** introduced by Representative David Knight January 10<sup>th</sup>, is "reaffirming support for the constitutionally protected right to hunt and fish in Georgia, asserting Georgia's primacy in the management of the state's fish and wildlife resources." Current concerns arise from a National Park Service study that may recommend creating a *national* park along a 50-mile stretch of the River between Macon and Hawkinsville, which would interfere with the Georgia Department of Natural Resources (DNR) control and regulation of that property under Georgia laws and regulations.

# While in Georgia, President Biden Pushes for Federal Control of Elections During his January 11<sup>th</sup> speech at Morehouse College and Clark Atlanta University, President Joe Biden, desperately, called for (a) abolishing the Senate filibuster rule, to allow the (b) national election bill (federal take-over of elections) to pass the Senate by a simple majority.

- (a) **Governor Kemp:** In his statement to *Newsweek*, Governor Kemp said the Biden administration has ignored "facts and evidence in an effort to distract from their many failures and rally their base around an unconstitutional, federal takeover of elections." Then, Governor Kemp defended Georgia's election law with this: "Senate Bill 202, the Election Integrity Act, makes it easy to vote and hard to cheat. The bill expands early voting opportunities, secures drop boxes around the clock, reduces long lines at polling places, and implements the same voter ID requirement for absentee ballots that we have had for in-person voting for well over a decade."
- **(b) Filibuster** is a delaying tactic to prevent or delay action on legislation in the Senate. The U.S. Senate explains it this way: "Prior to 1917 the Senate rules did not provide a way to end debate and force a vote on a measure. That year, the Senate adopted a rule to allow a two-thirds majority to end a filibuster, a procedure known as 'cloture.' In 1975 the Senate reduced the number of votes required for cloture from two-thirds of senators voting to three-fifths of all senators duly chosen and sworn, or 60 of the 100-member Senate."

#### **Action: Stop Federal Take-Over of Elections!**

- **H.R. 1 For the People Act**, introduced by Congressman. Sarbanes (D-MD) January 4, 2021, is an 886-page federal take-over of elections. It implements massive changes and strips away the constitutional right of states to control elections. <u>It passed the House 220-210 March 3, 2021</u> and was scheduled for a Senate vote March 24, 2021. However, it stalled in the Senate and the Administration is working feverishly to abolish the filibuster, so a simple majority can pass it.
- **H.R. 1 would cause massive changes**, such as (a) Internet voter registration and data up-dates; (b) automatic registration, (c) same-day registration and voting, (d) no proof-of-residency; (e) no cross-checking with other states for double voting; (f) no restriction on curbside voting; (g) state grants could fund election activity for minors; (h) minors under age 18 could register to vote; (i) no proof-of-citizenship required; (j) no voter ID required; (k) felons could vote when on probation, upon completion of sentence or otherwise released from prison.

**ACTION – Oppose.** Ask Georgia's U.S. Senators to vote NO. Senator Jon Osoff, 202 224-3521 and Senator Raphael Warnock, 202 224-3643 or call both toll-free in D.C. at 1 877 762-8762.

### **Action: Stop Non-Citizen Voting in Georgia!**

**H.B. 228 Proper ID for Voting in Georgia,** introduced February 2, 2021 by Representative Charlice Byrd, prohibits non-citizen voting and requires "A temporary license, permit, or special identification card" issued by Georgia to include the following term in a prominent place: "BEARER NOT A U.S. CITIZEN – NOT VOTER ID." In 2021, this bill was left in committee and remains alive for action this session.
