
What’s Happening? “Glitches” or Fraud?

“There is now a pattern of events we have uncovered across the country where votes are being taken from Republicans at all levels and transferred to competing Democrats in offsetting amounts. These are not random because in every case votes are moved from Republicans to Democrats. This is beginning to appear like a strategy used by the Democrats to steal this election.”

As of today, the Presidential Election has not been decided. However, the following smattering of reports may provide a modicum of hope that truth will emerge, that fraud will be exposed, and a constitutional remedy will be applied.

November 3, 2020. In *Rock County Wisconsin* at 11:12 p.m. President Trump was some 1,000 votes ahead of Biden. At 11:43 more votes came in, Trump had 46,649 to Biden’s 37,133 – a 9,516 lead for Trump. At 11:57 *votes were swapped* to give Biden 46,649, and Trump 37,133.

November 9, 2020. Numerous election events dubbed “glitches” were uncovered in *Wisconsin*, causing about 10,000 votes to go back to President Trump. Nearly 20,000 were moved from Trump to Biden. In *Georgia* approximately 6,000 votes were switched to Biden from Trump.

November 10, 2020. Congressman Doug Collins and Georgia Republican Party Chairman David Shafer’s letter to Secretary of State (SOS) Raffensperger requested a ballot recount, re-canvass and corrective action, including a full hand recount prior to certification. (O.C.G.A. 21-2-495) Also, they suggested five points of action to remedy the situation.

November 12, 2020. A letter from Chairman Shafer to the SOS and the State Election Board warned that out-of-state individuals and organizations plan to move to Georgia to vote in the run-off¹. Footnotes list 20 more out-of-state voters planning to “move” to Georgia to do so.

Page three, also, tells the SOS to (a) direct county registrars to report new voter registrations between November 3 and December 7, 2020 within 24 hours to the SOS office; (b) investigate such registrations to determine intent to move and possible legal violations. (c) If such is not feasible before the election, segregate all run-off ballots until validity is proven.

ACTION – Ask Governor Kemp to require strict investigation of all out-of-state applications for state residency and voter registration that occur before December 7, 2020. The Governor’s office number is 404 656-1776.

Georgia Election Law

Penalty for Violations: One-to-Ten Years Prison, Plus \$100,000 Fine

O.C.G.A. 21-2-572 voting in another state election, and again in Georgia’s election, is a felony.

O.C.G.A. 21-2-216(a) moving temporarily to vote in the run-off is illegal, potentially felonious.

O.C.G.A. 21-2-217 becoming a resident *requires* the intent to remain an inhabitant of Georgia.

O.C.G.A. 21-2-561 knowing that requirements aren’t met makes it a felony to register to vote.

O.C.G.A. 21-2-571 likewise, it’s a felony to vote or attempt to vote without the required status.

Election Results May Be Overturned

“Trump Attorney Sidney Powell Says Election Results Ready to Overturn.”

November 15, 2020. *The Washington Examiner’s* Michael Lee, quoted these comments by Trump legal team attorney Sidney Powell when she appeared on *Sunday Morning Futures*: “President Trump won by not just hundreds of thousands of votes but by millions of votes that were shifted by this software that was designed expressly for that purpose. We have sworn testimony¹ of why the software was designed. It was designed to rig elections.”

November 16, 2020. Powell, said election results in multiple states are “getting ready to overturn.” *One America News* reported another of her statements, “They’re facing an election that was absolutely rigged. We are soaking in information through fire hoses of complicated mathematical alteration to the votes. We have identified the system capability that does it ... it does in fact exist, regardless of what the name of it is.”

She identified the software as Smartmatic², a program designed for the sole purpose of shifting voting results. Then, she said, “It was a feature of the system that was designed with a back door, so that people could watch in real time and calculate with an algorithm how many votes they needed to change to make the results they wanted to create.”

Did Trump win by a 70% landslide, 80,000,000 votes and 400+ electoral votes?

Who will be inaugurated January 20th? Wood said, “I think it’ll be Donald Trump! He won!”

November 13, 2020. Atlanta-based attorney Lin Wood, Jr., who is working with President Trump’s legal team, filed a lawsuit against Georgia Secretary of State Brad Raffensperger and four members of the State Election Board, seeking declaratory and injunctive relief on three counts³ concerning the November 3, 2020 Presidential Election.

During a recent interview on *The John Fredericks Show*⁴, Mr. Wood said (a) illegal votes were being counted in Georgia and (b) signatures were not verified per Georgia law. (c) Republican watchers were not allowed to oversee the counting. (d) Fulton County poll workers at State Farm Arena “closed” for the night, but resumed counting after poll watchers left. (e) The leaky urinal that stopped the counting was fixed in an hour. (f) There will be no run-off in Georgia; but (g) there will be a down-ballot vote. (g) State legislators will decide the Presidential Election as required by the 12th Amendment to *The Constitution of the United States*.

When asked what he believes will happen with his lawsuit, Wood said he expects an expedited review of his case in Georgia’s Northern District Court.

Evidence obtained already makes him 100 percent certain Georgia’s election will be thrown out, since there is zero integrity in the software used in the election. When asked, “Did Dominion software change votes?” He said, “Absolutely. This is a communist play book.”

¹ Qualifications of the witness who provided sworn testimony: “He was fully briefed on it, he saw it happen in other countries, it was exported internationally for profit by the people that are behind Smartmatic and Dominion,” said Powell.

² Rudy Giuliani said on Twitter, “Did you know a foreign company, DOMINION, was counting our vote in Michigan, Arizona, and Georgia and other states. But it was a front for SMARTMATIC, who was really doing the computing. Look up SMARTMATIC and tweet me what you think. It will all come out.”

Trump Legal Team Explains Evidence of Election Fraud

November 19, 2020. During the Washington, D.C. press conference at noon November 19th, legal representatives of President Trump – Rudy Giuliani, Sidney Powell and Jenna Ellis – outlined fraudulent practices found in the on-going investigation of the Presidential Election.

During that conference, Mr. Giuliani said all the violations they mentioned were included in the November 8, 2020 lawsuit of *Constantino vs. City of Detroit*, filed in Wayne County, Michigan. Since that case outlines suspected fraud in the Presidential Election, I located the lawsuit and am reporting the General Allegations made by poll workers Cheryl A. *Constantino and Edward P. McCall, Jr.* According to the lawsuit, they observed the following :

- Forging Ballots on the Qualified Voter List
- Illegal Voter Coaching and Identification Issues
- Changing Dates on Ballots
- Illegal Double Voting
- First Round of New Ballots

At approximately 4:00 a.m. November 4, 2020, tens of thousands of new ballots were brought into the counting room via a back door.

- Second Round of New Ballots

At approximately 9:00 p.m. Wednesday, November 4, 2020, numerous boxes of ballots were brought into the downtown Detroit TCF Center – the only facility in Wayne County authorized to count ballots.

- No Transparency – Denied Access
- Qualified Voter File Access
- Absentee Ballot Signatures
- Unsecured Ballots

Also in *Constantino vs. City of Detroit* five counts outline specific violations of certain sections of the Michigan Constitution and Michigan law. Those Counts and citations are as follows:

Requests of *Constantino vs. City of Detroit*

- (a) Have an independent non-partisan audit to determine election integrity
- (b) Withhold voter certification until the court decides
- (c) Issue a preliminary injunction prohibiting certification of election votes
- (d) Issue two orders: (1) void Presidential election results and (2) order a new election
- (e) Issue a protective order in the Motion for TRO, plus further relief

Trump Attorneys Reveal Election Fraud

“The will of the people in this country was that Donald Trump won in a landslide if we can get to the bottom of it, and I am determined to do that. I think we’ll find he had at least 80,000,000 votes.”

November 19, 2020 Press Conference in D.C. Former New York City Mayor **Rudy Giuliani** said there’s enough evidence of voter fraud in battleground states to prove President Trump won the election – probably by 50,000 votes in Michigan, alone. However, he made this distinction, “They carried it [the fraud] out in a corrupt city, not in Republican places.”

Pennsylvania. (a) Poll watchers in Pennsylvania were prohibited from doing their jobs. (b) Bags and stacks of illegal ballots were added to vote totals. (c) Handling ballots in liberal Pittsburgh and Philadelphia differed from the way votes were handled in conservative areas.

Michigan. After investigating the election in Michigan, Giuliani proclaimed that, if Detroit threw out the illegal ballots containing only Biden’s name, Trump would win Michigan.

Wisconsin. Giuliani said, “There are 60,000 ballots in Milwaukee County and 40,000 in Madison that, as far as we can tell ... don’t have applications. If you count the lawful votes, Trump won Wisconsin by a good margin.”

Trump Attorney **Sidney Powell** said, “President Trump won by a landslide. We are going to prove it. And we are going to reclaim the U.S.A. for the people who vote for freedom.”

November 17, 2020 Newsmax reported statements from **Sidney Powell**: “The election could not have been more rigged than it was. We know Dominion has a long history of rigging elections. That’s what it was created to do to begin with. We’ve introduced the affidavit of a person who worked with Maduro – a high ranking military officer who saw it all happen and explained how it worked – and it’s out for the public to see on my Twitter feed.”

“So don’t tell me there’s no evidence of fraud. We’ve got increasingly mounting evidence of significant fraud across multiple states that casts into question the validity of the elections in every swing state, including Nevada and Arizona, Michigan, Wisconsin, Georgia, and it went beyond that, too. The corruption is actually worldwide. It is going to upset a countless number of elections across this country and around the world.”

About election ballot-counting “glitches,” Powell said, “Their algorithms wouldn’t perform the functions they’d originally performed or were set to perform. They couldn’t make up the vote count. He [Trump] had gotten so many hundreds of thousands more than they planned. So, that’s when they had to stop the counting and come up with a way to backfill the votes or destroy votes for Trump while they fabricated votes for Biden.”

Election Official Fraud. Citing conduct by election officials in Detroit, Philadelphia and other cities, Trump campaign senior legal advisor, **Jenna Ellis**, said “It’s actually election official fraud. That cannot stand. The Constitution requires that the state legislatures are the ones that make election law. What has happened in this case is that state- and local-level officials and all the way up have changed the rules. They want to tear down the American system.”

ACTION – Pray for truth to be revealed and for state legislators to close legal loopholes that allow such conduct!
