Have You Figured Out What’s Happening Inside America? The Plan is Outlined Below

“Humanism is the denial of God, and the total affirmation of man.

Humanism is really nothing else but Marxism.” – Karl Marx

To understand what’s happening in America, you need to read only three publications by the American Humanist Association – *Humanist Manifesto I* (1933), *Humanist Manifesto II* (1973) and *Humanist Manifesto 2000: A Call for a New Planetary Humanism*. These documents outline the atheistic plan to destroy Christianity and merge all nations into a transnational world government they identify as “internationalism.”

To be clear, humanism is an atheistic religion with published plans to overthrow belief in God and politically control His creation *via* world government. The 1961 U.S. Supreme Court identified humanism as a religion in *Torcaso v. Watkins* and the Georgia Court of Appeals did so in its *Spillers v. State* ruling in 1978. Prayer was taken out of U.S. public schools in 1962.

In 1972 John Steinbacher, managing editor of *American Mercury* in Torrance, California, wrote a powerful article explaining what was happening then and continues now. His article, “To Capture a Nation, Change the Religion”, accurately pinpointed humanism as a dangerous dual threat – on religion to specifically eradicate Christianity and on countries to usher in globalism.

With that dual purpose, *Manifesto I* used only one page to reject God and a half page to outline the plan to take charge of the universe, destroy the free enterprise system (U.S. capitalism) and restructure all associations and institutions. The end result they expect: establishment of a seamless world socialism and cooperative economic order. Skeptical? Ask Joe, the plumber.

That plan was “fleshed-out” 40 years later in *Humanist Manifesto II*, as humanists identified a set of common tenets to unite them for action. Claiming, “No deity will save us; we must save ourselves,” they replaced God’s values with man’s situation ethics, compassion¹ and empathy.

To create an anything-goes-land, humanists embraced their idea of morality – abortion, divorce, all sexual orientations and behaviors – and continued foisting it upon the culture, along with endorsement of suicide, assisted suicide and euthanasia. Their “separation of church and state” phrase, erroneously said to be in the U.S. Constitution is, actually, a humanist doctrine used to eliminate the influence of God in everything – morals, politics, religion, education.

Manifesto II describes the planned world community as a transnational federal government, a world court, world law, world order, no absolute values, no borders or travel restrictions. War and weapons would be obsolete. So, in 1973 humanists confirmed support for a global regime and put their trust in negotiators, environmentalists and socialists to solve humanity’s problems.

Humanist Manifesto 2000, A Call For A New Planetary Humanism repeated previous doctrines that humanists not only deny the Creator but are working to create a world government. Their document, *A Secular Humanist Declaration*, was published in 1980 to counteract objections to humanistic teachings in public schools. In 1988 their *Declaration of Global Interdependence*¹ continued the affirmation that humanists support global ethics and a global community.

Manifesto 2000 says “a new Planetary Humanism can provide meaningful directions for the future” by *removing controls* on scientific research but *strengthening controls* over technology, population growth and weapons of mass destruction. The socialist agenda in *Manifesto 2000* is openly stated. It recommends “harnessing the wealth of the world to provide capital, technical aid and education” across the planet. It endorses international regulation of the supposed global warming and greenhouse gases, including carbon² dioxide. Humanists are protectionists for all endangered species and provide intermediate technologies for poor³ folks, *but* would reduce the use of energy, lower living standards of the affluent, and limit business expansion and fishing⁴.

Manifesto 2000 recommends coexistence of multiple moral codes and proposes ethical choices based on individual interests, wants, needs and personal values. It argues *against* capital punishment, but *for* death with dignity, the hospice movement, freedom for competent adults to refuse medical treatment, surrogate motherhood, genetic engineering and cloning.⁵

Chapter VII of *Manifesto 2000* entitled, “A Planetary Bill of Rights and Responsibilities,” incorporates the Universal Declaration of Human Rights intended to invade the privacy of our homes, families and communities. It would have everyone receive internationally prescribed nutrition, shelter, protection, and employment, plus unemployment insurance and social security payments. It endorses consensual sexual conduct; marriage or partnerships between or among any combination of sexes; equal rights for homosexuals, bisexuals, transgendered identities and transsexuals; but prohibits sex with or marriage to children. It extends to women the personal right to privacy “to control their own bodies” *via* voluntary contraception and abortion.

Manifesto 2000 recommends the creation of a world parliament, similar to the European Parliament. It would be elected by popular vote and would enact international laws to replace national laws. An international judiciary would enforce world court rulings and international regulations would control all business. A transnational planetary agency would establish environmental regulations and impose a global tax to finance world government agencies.

Flu Vaccinations and Emergency Powers

Georgia governors received extensive emergency powers when S.B. 385 passed in 2002. It was Georgia's version of the Model State Emergency Health Plan the CDC wanted passed in every state. S.B. 385 gave Georgia governors total emergency power. In case of enemy attack or an actual or perceived public health emergency here or in the U.S. the governor has power to mandate vaccinations, quarantine and surveillance. Patients that claim religious exemptions or prefer to abide by their doctor's opinion may not escape inoculation in declared emergencies. S.B. 385 nullified religious exemptions and minimized the weight of doctors' opinions in such crises. When emergency mandates are challenged, judges will decide who gets the shots.

S.B. 385 has *some* safeguards. If a governor in Georgia needs to declare a state of emergency, he must call the General Assembly into special session to convene at 8:00 A.M. the second day after his declaration. Legislators may vote to concur with his decision or terminate the state of emergency. In any case, a state of emergency may not continue over 30 days, unless the governor renews it. However, the General Assembly is authorized to terminate it at any time.

Why is this law important now? Until last fall Georgia had a long-time policy allowing flu shots to be given without a prescription. But that changed in 2008 when the Georgia Board of Medical Examiners and the State Attorney General decided flu vaccines are dangerous and could no longer be given without a prescription.

On January 29, 2009 Representative Jimmy Pruettt introduced H.B. 217 that established a vaccine protocol to allow flu shots without prescriptions. It passed the House unchanged on February 17th and went to the Senate, where it was amended to strengthen the governor's emergency powers. Three words "pandemic influenza emergency" were added to Georgia Code Sections 38-3-3 and 38-3-51 so flu shots could be mandated in declared flu pandemics.

The House agreed with the Senate version on April 3rd and the governor signed it April 28th, two days after the U.S. Department of Health & Human Services categorized H1N1 (formerly swine flu) as a worldwide public health threat on April 26th. Though it has now spread to other countries, the H1N1 virus was initially discovered in mid-April in Mexico.

A connection between flu shots and the North American Union¹

Americans already skeptical about mandatory vaccinations administered by the U.S. may not know this. It could get worse if the North American Union is activated as planned in meetings held in 2005, 2006 and 2007 between George W. Bush and the leaders of Mexico and Canada.

At the first meeting on March 23, 2005 the three men committed their countries to building a North American Community by 2010, with a common outer security border with no boundaries between countries. A permanent tribunal would resolve disputes that occur throughout North America. Also, Mexican laborers and trucks could freely access all three countries and illegal aliens would be incorporated into the U.S. Social Security system. *But that's just the beginning!* *Over 20 U.S. committees are now working to ease the U.S. into a North American Union.*

The third meeting, August 21, 2007, produced a 44-page plan for a "Coordinating Body" using UN and NAFTA guidelines to write a flu epidemic protocol. U.S. angst could skyrocket when citizens must abide by policies set by a committee chaired by foreigners two years out of three.

Pay Czar Cuts 125 Executive Salaries & Plans to Cut More in 28 Businesses

The pay czar is dictating policy to businesses that accepted bailout money.

Likewise, the faith-based czar can dictate policy to recipients of faith-based funding.

Those that don't see the dangers of taking government money should be getting the picture now. On October 22nd the media reported that Kenneth Feinberg, appointed in June 2009 to be President Obama's Special Master on Executive Pay (pay czar), cut by 50- to 90-percent the salaries and bonuses of 125 executives in seven companies that accepted bailout money. Also, he's said to be considering the same treatment for well-paid executives in 28 other companies, though those businesses are operating on their own money, not on a government bailout.

Since 2002 and continuing in 2009 with Representative Neal's H.R. 567, several attempts have been made to repeal Georgia's constitutional ban against tax revenue going to religions. H.R. 567 must be defeated. If a pay czar can control private companies that take federal money, the faith-based czar can and will purge every vestige of religion out of social services funded by federal money. Currently in Georgia, religious social services may receive *federal* funds, but not directly. They must be funneled through the state before they're distributed.

The matter surfaced after President Bush issued EO 13199, January 29, 2001, to establish the *White House Office of Faith-Based & Community Initiatives* to give religious social services access to federal grants. February 9, 2009 President Obama rewrote it with EO 13498, making it a personal project as the *President's Advisory Council for Faith-Based & Neighborhood¹ Partnerships*. Also in February, Obama made 26-year-old Joshua DuBois his faith-based czar, added strict federal oversight and training for workers in such programs, but gave the president power over policy, programs and practices for groups taking grants. DuBois had worked for Obama since 2005 and in 2008 was web blogger for the pro-Obama "Organizing for America" campaign. Now at age 26, Joshua DuBois is a powerful czar answering only to the president.
