### **DANGER!** Equality Act, Half-way through Congress

"The Chamber looks forward to the enactment of the Equality Act."

**H.R. 5**, introduced by U.S. Congressman D. N. Cicilline (D-RI-1) March 13, 2019, passed the U.S. House May 17<sup>th</sup> and is in the Senate Judiciary Committee, where it needs to die.

# Congressional Overview of H.R. 5

- H.R. 5, specifically, prohibits discrimination or segregation based on sex, sexual orientation, and gender identity in public accommodations<sup>1</sup> and facilities, education, federal funding, employment, housing, credit, and the jury system. [Discriminates against biological sexes.]
- H.R. 5 allows the Department of Justice to intervene in equal protection actions in federal court on account of sexual orientation or gender identity. [*Pits DOJ against heterosexuals.*]
- H.R, 5 prohibits discrimination based on (1) associating with a person in a protected class; or (2) anyone perceived or believed to be in a protected class. [Denies freedom of association.]
- H.R. 5 prohibits the Religious<sup>2</sup> Freedom Restoration Act of 1993 from providing a claim, defense, or basis for challenging such protection. [Denies use of religious freedom laws.]
- Access to shared facilities, including restrooms, locker rooms, and dressing rooms cannot be denied to anyone claiming an opposite-sex gender identity preference. [Destroys privacy.]

H.R. 5 deletes the word "sex" from the 1964 Civil Rights Act and replaces it with "sex, sexual orientation, gender identity" to federally protect sexual behaviors. The Democrat House Judiciary chairman's expression of support: "Religion is no excuse for discrimination when it comes to sexual orientation or gender identity." [Protects sexual acts, defies religious beliefs.]

H.R. 5 would render illegal the constitutional right to religious freedom. Federal departments and agencies could penalize churches, religious schools, and organizations for expressing faith-based beliefs about marriage, sexual morality and distinguishing between males and females.

Such penalties include the loss of federal funding for women's shelters, unless biological men who identify as women are allowed to share with women the shelter's sleeping facilities. Also, Adoption/foster care agencies lose funds if placement is only to married, opposite-sex couples.

#### **Sound Bites**

- Churches will be forced to host same-sex ceremonies or lose tax-exempt status.
- Noncompliant religious colleges lose accreditation and become ineligible for student loans.
- On overnight trips, religious entities could not segregate sleeping space by biological sex.
- Churches would be forced to hire LGBTQ+ child care staff, and allow them to diaper.

<sup>2</sup> H.R. 5 does not include a religious exemption and prohibits the use of federal and state RFRA laws to defend beliefs.

Expands public accommodations definition to include places or establishments that provide (1) exhibitions, recreation, exercise, amusement, gatherings, or displays; (2) goods, services, or programs; and (3) transportation services.

# Multiple Discriminations in H.B. 580, Georgia's Conversion Therapy Ban<sup>1</sup>

H.B. 580 would be a Red Stop Light for Conservative Counselors and a Green Go-Ahead Light for Compliant Counselors.
H.B. 580 Affirms Pro LGBTQ+ Counseling Strategies and Penalizes Negative Counseling about LGBTQ+.
H.B. 580 Denies Religious Freedom and Overrides Parental Rights

While protection of alternate lifestyle decisions is the overt focus of H.B. 580, other critically important questions raised by this bill are (a) whether speech as defined in H.B. 580 should be politically controlled; (b) whether freedom of speech is constitutionally protected; (c) whether parents' right to influence children's lifestyles can be nullified; (d) whether religious speech, expression and association are constitutionally protected for parents, minors and professionals; and (e) whether local governmental power supersedes *The Constitution of the United States*.

**H.B. 580 Practice of Conversion Therapy, Prohibit,** introduced by Representative Matthew Wilson in the Georgia General Assembly on March 7<sup>th</sup>, endangers established moral standards. It (a) prohibits counseling against sexual orientation and gender identity, (b) but authorizes positive counseling and assistance toward personal adoption of variant lifestyles. Violators will be deemed unprofessional and subject to discipline or loss of professional licenses.

Although it failed to pass in 2019, H.B. 580 is alive for the 2020 session. If it passes and is not vetoed, the state could intervene in patient/counselor discussions and treatment, intrude into parental authority over minor children, interfere with the constitutional right to free speech, and limit the freedoms of religious speech, expression and association. Such facts are in the bill.

H.B. 580 changes laws for professional counselors, physicians and psychologists.

43-10A-2.1 applies to counselors; 43-34-22.1 covers physicians; 43-39-6.1 limits psychologists. Paragraphs (a), (b) and (c) are worded identically in each section and are outlined as follows:

Each paragraph (a) entitles the new law the "Youth Mental Health Protection Act."

Each paragraph (b) explains what the new law authorizes and what it prohibits, as follows:

- 1. H.B. 580 *prohibits* conversion therapy or treatment if it is designed to (a) change a person's sexual orientation or gender identity or (b) behavior or expression or (c) eliminate or reduce sexual attractions or feelings toward the same gender<sup>2</sup>.
- 2. Contrarily, H.B. 580 *specifically authorizes* professional counselors to *affirm and assist* anyone in transition and *affirm variant lifestyle choices* for those struggling to decide.

# Each paragraph (c) makes two points:

- 1. Anyone under age 18 cannot be subjected to conversion therapy; [Defies parental control.]
- 2. Violators of this new law will be considered unconstitutional and could lose licensure.

# "Bring Your Bible to School Day" Began in 2014

The Washington Post announced the first Bring Your Bible to School Day on October 16, 2014, its initial day of observance. Also, the Post cited legal advice from Alliance Defending Freedom that reminded schools of students' rights to bring Bibles to school, then distribute and discuss them with classmates during non-instructional time – at lunch, while walking between classes, as well as before and after school. Also, ADF cautioned schools NOT to censor the Bible, unless identical standards apply to activities schools allow during non-instructional time.
