

Act Now! Decatur City School Board to Consider Transgender Policy

In a July 26, 2016 memo to his staff City Schools of Decatur Superintendent David Dude quietly began implementing radically new transgender guidelines. That memo, **reprinted verbatim** in bold font, is as follows:

"To be clear, here are some examples of situations related to gender identity and how I expect them to be handled in compliance with this policy. For purpose of these examples, assume this student was assigned the sex of male at birth and now identifies as female.

- **This student should be treated the same as any other female student.**
- **She should not be identified as anything other than female.**
- **She should be allowed to use the female restroom.**
- **She should be allowed to use the female locker room.**
- **She should be allowed to try out for 'female' sports.**
- **She should be allowed to room with other females on field trips."**

A Parental Rights Amendment to the Constitution is *LONG* Over-due!

Since 2008 Congress has rejected at least a dozen¹ proposed Parental Rights Amendments, but a new bill to restore parental rights was introduced on August 1, 2017 by Senators Graham, Blunt, Isakson, Risch, Grassley and Rubio. S.J. Res. 48 refers to six areas U.S. parental authority may be or is being restricted, minimized, threatened, or globally influenced. S.J. Res. 48 states:

Senate Joint Resolution, S.J. Res. 48

"SECTION 1. The liberty of parents to direct the upbringing, education, and care of their children is a fundamental right.

"SECTION 2. The parental right to direct education includes the right to choose, as an alternative to public education, private, religious, or home schools, and the right to make reasonable choices within public schools for one's child.

"SECTION 3. Neither the United States nor any State shall infringe these rights without demonstrating that its governmental interest as applied to the person is of the highest order and not otherwise served.

"SECTION 4. The parental rights guaranteed by this article shall not be denied or abridged on account of disability.

"SECTION 5. This article shall not be construed to apply to a parental action or decision that would end life.

"SECTION 6. No treaty may be adopted nor shall any source of international law be employed to supersede, modify, interpret, or apply to the rights guaranteed by this article."

Gender Ideology Harms Children (Especially, Note Fact No. 8)

American College of Pediatricians Policy Statement

- 1. Human sexuality is an objective biological binary trait: “XY” and “XX” are genetic markers of male and female, respectively – not genetic markers of a disorder.** Disorders of sex development (DSDs), including but not limited to testicular feminization and congenital adrenal hyperplasia, are ... rightly recognized as disorders of human design. “Intersex” is not a third sex.
- 2. No one is born with a gender. Everyone is born with a biological sex. Gender (an awareness and sense of oneself as male or female) is a sociological and psychological concept; not an objective biological one.** Those questioning gender do not comprise a third sex.
- 3. A person’s belief that he or she is something they are not is, at best, a sign of confused thinking.** The psychodynamic and social learning theories of GD/GID have never been disproved.
- 4. Puberty is not a disease and puberty-blocking hormones can be dangerous.** Such hormones induce a state of disease (absence of puberty), inhibiting growth and fertility in biologically healthy child.
- 5. According to the DSM-5, as many as 98% of gender confused boys and 88% of gender confused girls eventually accept their biological sex after naturally passing through puberty.**
- 6. Pre-pubertal children diagnosed with gender dysphoria may be given puberty blockers as young as eleven, and will require cross-sex hormones in later adolescence to continue impersonating the opposite sex. These children will never be able to conceive any genetically related children even via artificial reproductive technology. In addition, cross-sex hormones (testosterone and estrogen) are associated with dangerous health risks including but not limited to cardiac disease, high blood pressure, blood clots, stroke, diabetes, and cancer.**
- 7. Rates of suicide are nearly twenty times greater among adults who use cross-sex hormones and undergo sex reassignment surgery, even in Sweden which is among the most LGBTQ – affirming countries.** Who would condemn children to this knowing that as many as 88% of girls, 98% of boys will eventually accept reality and achieve a state of mental and physical health?
- 8. Conditioning children into believing a lifetime of chemical and surgical impersonation of the opposite sex is normal and healthful is child abuse.** Endorsing gender discordance as normal ... will confuse children and parents, leading more children to ... be given puberty-blocking drugs.

Drag Queen Story Hour: Ponce de Leon Branch Library September 30, 3:00 p.m.

“I’m home from the drag queen indoctrination hour. May God have mercy upon us. This ‘event’ was staged from start to finish. The star of the show was the size of an NFL linebacker in a huge red curly wig and stage makeup in a multicolored dress. During the reading of the story he/she/it would casually flip her hair backwards and give little clues to the children. ‘The little boy in the story likes to dance. Do YOU like to dance? FDA Tested Food & Vaccines for Pesticides, but not for Herbicides, Until Now

Description of FDA Safe-Food Testing: “Before allowing the use of a pesticide¹ on food crops, we set a tolerance, or maximum residue limit, which is the amount of pesticide residue allowed to remain in or on each treated food commodity.... The tolerance is the residue level that triggers enforcement actions. That is, if residues are found above that level, the commodity will be subject to seizure by the government.”

– “Setting Tolerances for **Pesticide Residues in Foods**,” U.S. Environmental Protection Agency (EPA)

I. EPA, responsible for ensuring the safety of the food supply for human consumption, has done so by (a) regulating how much of which **pesticide** [but not herbicides] may be in and on foods, (b) then setting limits – tolerances – for **pesticide** residues in foods and animal feeds. Acceptable levels have been determined as follows:

- The toxicity of the **pesticide** and its break-down products; (harmful effects)
- How much of the **pesticide** is applied and how often; (cumulative effects)
- How much **pesticide** residue remains in or on food when it’s marketed and prepared; (duration)
- All possible routes of exposure from residue on crops, in drinking water, and to residents. (paths)

II. *Glyphosate*² (*Roundup*) and hundreds of other **herbicides** have been found in **vaccines**. At the request of Moms Across America (MAA) *Microbe Inotech Laboratories, Inc.*, in St. Louis, tested vaccines and reported the amounts of glyphosate in the following:

<i>MMR II (Merk) vaccine</i>	2.671 ppb ³ of glyphosate
<i>DTap Adacel (Sanofi Pasteur) vaccine</i>	0.123 ppb of glyphosate
<i>Influenza Fluvirin (Novartis)</i>	0.331 ppb of glyphosate
<i>HepB Energix-B (Glaxo Smith Kline)</i>	0.325 ppb of glyphosate
<i>Pneumococcal Vax Polyvalent Pneumovax 23 (Merk)</i>	0.107 ppb of glyphosate

MM II vaccines had levels of glyphosate up to 25 times higher than other vaccines. *Further independent tests* confirmed these findings at or above the same levels.

MIT scientist Dr. Stephanie Seneff stated, “Glyphosate could easily be present in vaccines due to the fact that certain vaccine viruses including measles in MMR⁴ and flu are grown on gelatin derived from the ligaments of pigs fed heavy doses of glyphosate in feed made from GMO (genetically modified organism) products. Gelatin comes from collagen that has lots of glycine. The EPA allows livestock feed to have up to 400 PPM (parts per million) of glyphosate residue, thousands of times higher than has been shown to cause harm in numerous studies.”

Dr. Toni Bark, the founder/director of Center for Disease Prevention and Reversal, was deeply concerned about injecting the known non-selective weed killer, glyphosate, directly into a child. She said: “**Neither Roundup nor glyphosate has been tested for safety as an injectable.** Injected toxins, even in minute doses can have profound effects on the organs and the different systems of the body. ... Since glyphosate is heavily used in corn, soy, wheat, cotton and other commodities, we can expect to see more severe food allergies in the vaccine recipients. In addition, chemicals in ultralow doses can have powerful effects on physiology, behaving almost as hormones, stimulating or suppressing physiological receptors.”

California: Glyphosate added to List of Cancer-Causing Chemicals

On March 28, 2017, the Office of Environmental Health Hazard Assessment posted a Notice on its website that glyphosate would be added to the list of chemicals known to the state to cause cancer. Therefore, glyphosate was added to the Proposition 65 list on July 7 2017.

May 5, 2017, Mission Viejo, California. When Moms Across America (MAA) released findings of toxins in 36 American children tested at Great Plains Laboratory, along with the Canadian Food Inspection Agency (CFIA), the following analysis was included:

“100 % of all the children tested positive for serious toxins. 79 % of the children tested had ADHD or autism symptoms, 21 % did not. Over 50 % tested positive levels of three-times higher than the average. We expected the children who ate organic to have lower levels of toxins than the children who did not. This was not the case for the majority of the children. Upon the release of the Canadian Food Inspection Agency (CFIA) glyphosate data, we realized why, and we hope consumer and food manufacturers take note of these important findings.”

In 2015 the International Agency for Research on Cancer concluded that glyphosate is a “probable human carcinogen,” with a “positive association” between glyphosate and blood cancers called non-Hodgkin lymphoma. IARC considered some 1,000 published studies when evaluating glyphosate. Many used laboratory experiments; only a few used real-life exposure.

In the U.S. in early 2016, FDA began limited testing for glyphosate – the most widely used herbicide in the world – the active ingredient in Monsanto’s Roundup. Brief research in 2016 was suspended, but resumed, according to Freedom of Information Act documents. A 2015 California court ruled that Roundup could be required to use a label warning that it may cause cancer. On July 7, 2017 glyphosate was put on California’s carcinogenic chemicals list.

How Glyphosate Impacts the Body, by MIT PhD. Scientist Stephanie Seneff

- *Kills good bacteria:* Glyphosate, an antimicrobial agent (antibiotic), preferentially kills good bacteria. Result: pathogens overgrow in the gut and lead to gut leakage and inflammation.
- *Causes toxicity and deficiencies:* As glyphosate chelates rare minerals – manganese, cobalt, molybdenum, copper, iron, sulfur, selenium, etc. – it disrupts management of very important bodily nutrients. Minerals pile up in the wrong places, causing both toxicity and deficiency.
- *Disrupts liver function:* Glyphosate disrupts certain enzymes in the liver, which are important for many things, two of which activate vitamin D and detoxify toxic chemicals and drugs. Acetaminophen (Tylenol), for example, becomes toxic when these enzymes aren’t working.
- *Increases harm from vaccines:* Glyphosate works synergistically with aluminum, mercury, and glutamate in vaccines to cause much greater harm than could be the case if there were no glyphosate present in the blood when the vaccine was administered.
- *Interferes with essential amino acid production:* Glyphosate interferes with the shikimate pathway, used by microbes and plants to produce essential aromatic amino acids. Our cells that don’t have this pathway depend upon food and gut microbes to synthesize amino acids. Since essential aromatic amino acids cannot be synthesized, they must be supplied by food. Glyphosate residue on consumed food interferes with the synthesizing process.
